## **WOULDHAM PARISH COUNCIL. FINANCIAL DETAILS FOR REPAYMENT OF LOAN**

Six tenders were received by Wouldham PC to tarmac the car park at Knowle Road.

The Clerk, Chair and Vice Chair opened and discussed them together, this conversation was taped.

They have recommended CW Surfacing. This Company have just won contract for large car park in Broadstairs, Tudor Park Hotel and Queen Mary Hospital Sidcup.

## **BORROWING**

£65000 OVER 5 YEARS. Repayment £12444.oo per annum

The first payment of £6222 would be made from savings

This leaves 10 more payments from the precept.

The above table shows our precept requirements for the previous 3 years.

Parish Council costs have remained mostly the same.

With the rise in our tax base we kept the Band D the same in order to make our first payment for the car park loan (estimated £6222 per 6 months)

We expect the Tax Base to rise by 100 homes to approx. 697 homes for the next financial year. (currently being built)

The final total of new homes in our Parish is expected to be 1200 so we have assumed a 100 homes a year increase in the tax base.

I will assume a 2% p.a. increase in PC costs. This table shows the outcome if building stopped next year at 697 homes to show how the financial cost of the loan would be met.

As you can see, regardless of the amount of new homes built the increase in the precept will be 5.8% in the first year although in every scenario this will reduce or only increase by 1.2% in the following years.

## **PATHWAY**

The quote for the pathway across the Recreation Ground to meet the car park is £33195. We are getting £15000 from KCC leaving £18195

We can easily pay this from our savings of £30400 (total for pathway and first loan repayment £24417)

Another option is to add this to the borrowing (Parish Council agree to pay from savings)
