## RE: WO No. ROYAL MAIL POST BOX INSTALLATION AT VILLAGE ROAD, ST. PETERS VILLAGE, WOULDHAM, ROCHESTER, KENT ME1 3GD

I record below the terms which are acceptable to Royal Mail Group Limited (Royal Mail) for the installation and retention of a new Post Box on your company's property.

- The Post Box shall be of the Royal Mail freestanding type. It will be sited at Village Road, St. Peters Village, Wouldham, Rochester, Kent ME1 3GD in the position approximately shown on the photo annexed to this letter.
- No payment or licence fee shall be due from Royal Mail in respect of the continued retention of the Post Box on your company's land.
- The installation of a Royal Mail Post Box shall be carried out by Royal Mail at its own cost, in a proper and workmanlike manner and according to the Method Statement annexed to this letter.
- 4. This agreement for the retention of the Post Box may be terminated by either party giving to the other not less than three months' written notice. Should Royal Mail cease to use the Post Box, or should it be damaged beyond repair, then either party may terminate this agreement forthwith.





- On termination of the agreement for the retention of the Post Box, Royal Mail shall forthwith remove the same and make good the site to your company's reasonable satisfaction.
- Royal Mail will indemnify your company against any claims or demands whatsoever arising, out of the installation of the Post Box, its condition, state of repair or use by the general public, up to the sum of One Thousand Pounds (£1,000.00)
- Royal Mail will keep the Post Box in good condition and will repaint the same as and when it may be necessary.

Finally, I acknowledge that Royal Mail Group Limited will not be entitled to any legal or other rights in the site of the Post Box other than a bare licence, which may be terminated in the manner specified above.

I would be obliged if you could kindly confirm your agreement to the above terms by returning this letter duly signed.




#### **METHOD STATEMENT:**

## WOULDHAM PARISH COUNCIL Highways Committee

#### TERMS OF REFERENCE

Put to Wouldham Parish Council on December 3rd 2019

#### 1. MEMBERSHIP

- 1.1 The Committee shall consist of **3** Parish Councillors, who shall be elected each year at the Annual Meeting of the Parish Council.
- 1.2 Existing Committee members are eligible for re-election.
- 1.3 The Committee may, at its discretion, invite non- Councillors whose expertise and knowledge will be beneficial to Committee deliberations.

#### 2. MEETINGS

- 2.1 During each Parish Council meeting the Highways Committee will report on any communications they have had with any outside bodies (KCC, TMBC etc.) or any outside persons on local Highways matters.
- 2.2 If a decision needs to be made at a meeting, then a report should be produced before this meeting.
- 2.3 All decisions of the committee shall be determined by a majority vote at the Parish Meeting. The Chair has the casting vote when there are equal numbers of votes.

### 3. REMIT OF THE HIGHWAYS COMMITTEE

- 3.1 The Committee has delegated powers from the full council to comment on communications from KCC or TMBC.
- 3.2 All Wouldham Parish Council members are notified of these comments prior to the meeting.
- 3.3 All Committee decisions will be recorded in the Parish Council Minutes.

#### REPORT TO WOULDHAM PARISH COUNCIL 3rd DECEMBER 2019

#### MR10 PROW UPDATE

1. MR10 has been a long standing but complex problem involving both KCC PROW and KCC Highways. We along with Peter Homewood have kept the pressure on these two organisations and at long last MR10 has been bought up to the standard of a rural Bridle Way passable in all weathers which is what it should be. To do this KCC Highways should have started work on 28th November on the junction of Burham Court Road and New Court Road to enable HGVs to turn left easily at the junction when exiting from Burham Court Road.

#### FIREWORKS COMPLAINTS

- 2. Fireworks are a great pleasure to many but they cause considerable distress to pets and their owners.
- 3. There is a campaign by the RSPCA that some residents have alerted us to and asked us to support in changing TMBC policy on the sale and control of fireworks. We have sought advice from our officers on this and their response is:

"The Firework Regulations 2004 already provides a number of controls similar to those sought as to the sale and use of fireworks by the General Public, including the type of firework, the dates on which they can be sold and the times at which they can be set off. The Enforcement of these regulations is primarily split between Trading Standards and the Police. Whilst the Borough Council does not have a remit under the 2004 Regulations, we can consider noise from individual firework displays in respect of a potential Statutory Noise Nuisance under the Environmental Protection Act 1990, however this only stretches to their nuisance value to humans and not animals."

4. We hope this makes TMBC's position clear.

#### WINTER SERVICE PLAN

5. At the JTB the Winter Road Servicing Plan was announced. All Wouldham "main" roads are down for clearance and gritting except School Lane and Hall Road. Note Hall Road is a problem for gritters because of humps. Details can be viewed at:
